CALL TO ORDER:

Chairman Seams called the Finance Committee meeting of the City of Lewisburg to order at 7:05 pm

Arts & Humanities Fund request, West Virginia Jazz Orchestra

Councilmember Pritt made a motion to recommend approval to City Council to approve the Arts & Humanities fund request from the WV Jazz Orchestra in an amount of \$700 for a Labor Day Celebration in the Green Space on Saturday, September 3, 2022 from 5:00 to 7:00 pm. Councilmember Little seconded the motion. With all in favor the motion carried.

Chapman Technical Group contract approval for storm water comprehensive study

Councilmember Pritt made a motion to recommend approval to City Council of the contract/master agreement with Chapman Technical Group for a storm water comprehensive plan. Mayor White seconded the motion. City Attorney White will review the contract/agreement for liability limits. With all in favor the motion carried.

Councilmember Little made a motion to approve Task Order 1 to master agreement for professional engineering services for storm water system improvements between the City of Lewisburg and Chapman Technical Group. Councilmember Elkins seconded the motion. With all in favor the motion carried.

Councilmember Little made a motion to approve Task Order 2 to master agreement for professional engineering services for field survey & data collection, watershed modeling & analysis and storm water system management for storm water system improvements between the City of Lewisburg and Chapman Technical Group in an amount not to exceed \$242,000. Councilmember Elkins seconded the motion. With all in favor the motion carried.

Water Treatment Plant, sediment pond cleaning bed approval

Councilmember Little made a motion to accept the bid from Greenbrier Excavating & Paving, Inc. in the amount of \$38,100 for a sediment pond cleaning contract contingent upon completion of the job. Mayor White seconded the motion. With all in favor the motion carried.

Approval of two alternate main water line extensions

City Manager Hill explained the City would be connecting Old Powell Road with Houfnagle Road. This will provide Houfnagle Road with fire protection in the future. The City will pay for the piping and the owners will pay for installation costs.

Councilmember Little made a motion to recommend approval to accept the bid from Citgo Water for the JD Loudermilk Extension in an amount not to exceed \$17,877.55. and not to exceed \$100,599.97 from Core & Main for the Old Powell Road to Houfnagle Road mainline extension. Mayor White seconded the motion. With all in favor the motion carried.

Jamison Sizemore, promotion to Crew Leader with related wage increase

Councilmember Pritt made a motion to recommend the promotion of Jamison Sizemore to crew leader with a related wage increase of 40 cents an hour to \$14.00 an hour. Councilmember Johnson seconded the motion. With all in favor the motion carried.

Employee vacation time accruals

Council member Johnson made a motion to increase the maximum vacation time accrual for full time employees to 120 hours per year. Councilmember Elkins seconded the motion. With all in favor the motion carried.

City Manager Hill stated that Dinsmore & Shohl has been developing the employee handbook. She noted it will be ready for review for the July 19, 2022 City Council meeting.

Employee picnic
