Minutes of City Council

April 18, 2023

Regular Session

The Council of the City of Lewisburg met in regular session on Tuesday, April 18, 2023 at 7:00 p.m. in the Paul R. Cooley Council Chambers at 942 Washington St. West, Lewisburg, WV also available VIA a Zoom Teleconference call.

CALL TO ORDER:

Mayor White called the meeting to order at 7:00 p.m.

ORDINANCE:

Ordinance 317

Treasurer Susan Honaker read the title of Ordinance 317 for second reading:

"AN ORDINANCE OF THE COUNCIL OF THE CITY OF LEWISBURG APPROVING AND ADOPTING THE 2023 REPLACEMENT PAGES TO THE CODIFIED ORDINANCES OF THE CITY OF LEWISBURG."

Mayor White opened a public hearing regarding Ordinance 317, hearing no comments from the public she closed the public hearing.

Councilmember Elkins made a motion to approve Ordinance 317 as presented on second reading. Councilmember Seams seconded the motion. With all in favor the motion carried.

Ordinance 318

Councilmember Elkins made a motion to approve Ordinance 318 on first reading. Council member Seams seconded the motion. With all in favor the motion carried.

Resolution 514, Water System Improvement Project Pay Request #10

The title of Resolution 514 was read for passage:

Councilmember Seams made a motion to approve Resolution 514. Councilmember Elkins seconded the motion. With all in favor the motion carried.

Resolution 513, Public Works Building Pay Request #3

The title of Resolution 513 was read for passage:

"RESOLUTION OF THE CITY OF LEWISBURG APPROVING INVOICES RELATING TO SERVICES FOR THE PUBLIC WORKS BUILDING CONSTRUCTION AND AUTHORIZING PAYMENT THEREOF."

Councilmember Seams made a motion to approve Resolution 513. Councilmember Johnson seconded the motion. With all in favor the motion carried.

Mayor White read a proclamation designating the month of April as Sexual Assault Awareness Week in Lewisburg.

Children's Memorial Flag Day

Mayor White read a proclamation proclaiming Friday, April 28, 2023 as Children's Memorial Flag Day in Lewisburg.

COMMUNICATIONS FROM THE MAYOR:

COMMUNICATIONS FROM THE CITY MANAGER:

Water System Construction on Greenbrier River Trail

City Manager Hill reported the City has had issues with pedestrians, cyclists and people riding horses on the small portion of the Greenbrier River Trail between Caldwell and Harper (Hopper) Road despite the fact the trail is still closed because of construction ongoing with the water system. She noted that some of the silt fences surrounding construction areas had been vandalized. She mentioned the City might have to post employees or hire a security team to monitor the area until the trail is re-opened later this summer.

Water System construction of water lines in downtown Lewisburg

City Manager Hill stated that construction work of the water lines related to the water system upgrade will continue to happen downtown. She noted there will be delays and inconveniences to motorists while construction occurs. She asked that motorists and citizens be patient and kind until construction is complete.

Public Works Building Construction update

City Manager Hill stated that digging should begin on the footers for the new Public Works building in the next two weeks.

Lay the Levy

City Manager Hill announced the levy rates:

The rates are as follows: Regular current levy rates: Class I .12.5/\$100 valuation, Class II .25.000/\$100 valuation and Class IV .50.000/\$100 valuation

Excess current levy rates: Class I .6.25/\$100 valuation, Class II .12.500 /\$100 valuation and Class IV .25.000/\$100 valuation.

City Council did not have any comments from the public regarding the laying of the levy.

Councilmember Seams made a motion to officially lay the levy for the General Fund. Councilmember Johnson seconded the motion. With all in favor the motion carried.

Appointment of Election Officials

Councilmember Elkins made a motion to approve the appointment of the list of election officials for the June 13, 2023 Municipal Election allowing City Clerk Beatty to find replacement poll workers if it proves necessary. Councilmember Seams seconded the motion. With all in favor motion carried.

Water System Improvement Project Change Order #8, Orders Construction

City Manager Hill explained that the change order was necessary because more materials were required to construct the road since it was being created over a creek bed and extra materials were needed to build up the road higher than the creek.

Councilmember Seams made a motion to approve Changer Order #8 with Orders Construction. Councilmember Johnson seconded the motion. With all in favor the motion carried.

Employee Appreciation Luncheon

Councilmember Seams made a motion to approve a quote from Jim's Drive In in the amount of \$600 to provide food for the employee appreciation luncheon on June 14, 2023 and a quote in the amount of \$42 from Wal-Mart for cupcakes for the employee luncheon; allowing employees to leave work for the day when the picnic is over. Councilmember Elkins seconded the motion. With all in favor the motion carried.

Councilmember Elkins made a motion to approve a quote for engraved Yeti cups from RIPCO in the amount of \$3,605 for the employee appreciation luncheon on June 14, 2023. Councilmember Johnson seconded the motion. With all in favor the motion carried.

Planning Commission Report

Planning Commission President Little reported on the following events of the April 6, 2023 Planning Commission working session meeting:

• The Planning Commission recommended approval of a conditional use permit to operate a three-bedroom plus Air BnB at 163 Randolph Street.

Planning Commission Chair Little opened the floor for discussion during a public hearing regarding the request to operate a three bedroom plus Air BnB at 163 Randoph Street by Lindsay Moran. Hearing no comments, the public hearing was closed.

Finance Committee Report

Finance Chair Arron Seams reported on the following items of interest from the April 11, 2023 Finance Committee meeting:

Arts and Humanities Fund request from the Lewisburg Literary Festival
