Minutes of City Council August 20, 2024 Regular Session

The Council of the City of Lewisburg met in regular session on Tuesday, August 20, 2024, at 7:00 p.m. in the Paul R. Cooley Council Chambers at 942 Washington St. West. Lewisburg, WV. available VIA a Zoom Teleconference call.

<u>CALL TO ORDER</u>: Mayor White called the meeting to order at 7:00 p.m.

ORDINANCES:

Ordinance 320, Updating the Codified Ordinances, first reading

City Clerk Shannon Beatty read the following ordinance by title for first reading:

Councilmember Seams made a motion to approve Ordinance 320 as presented. Councilmember Pritt seconded the motion. With Four (4) in favor and two (2) absent (Johnson and Little) the motion carried.

Ordinance 321, Stormwater Drainage, second reading & public hearing

City Clerk Shannon Beatty read the following ordinance by title for second reading:

"AN ORDINANCE OF THE COUNCIL OF THE CITY LEWISBURG, WEST VIRGINIA, TO RECODIFY AND RECODIFY CURRENT PART THIRTEEN, CHAPTER THREE, ARTICLE 1371 OF THE CITY CODE AS PART THIRTEEN, CHAPTER ONE, ARTICLE 1326 OF THE LEWISBURG CITY CODE"

City Clerk Shannon Beatty read the title of Resolution 559 for passage:

Councilmember Seams made a motion to approve Resolution 559 as presented. Councilmember Pritt seconded the motion. With Four (4) in favor and two (2) absent (Johnson and Little) the motion carried.

Resolution 560, Water Treatment Plant Improvement Project Pay Request #27

City Clerk Shannon Beatty read the title of Resolution 560 for passage:

"RESOLUTION OF THE CITY OF LEWISBURG APPROVING INVOICES RELATING TO SERVICES FOR THE WATER SYSTEM IMPROVEMENTS PROJECT AND AUTHORIZING PAYMENT THEREOF."

Councilmember Seams made a motion to approve Resolution 560 in the amount of \$398,722.63 for passage. Councilmember Johnson seconded the motion. With Four (4) in favor and two (2) absent (Johnson and Little) the motion carried.

Resolution 561, Stormwater Project Pay Request #9

City Clerk Shannon Beatty read the title of Resolution 561 for passage:

"RESOLUTION OF THE CITY OF LEWISBURG APPROVING INVOICES RELATING TO ENGINEERING SERVICES FOR THE CITY OF LEWISBURG STORMWATER ASSESSMENT AND MANAGEMENT STUDY AND AUTHORIZING PAYMENT THEREOF."

Councilmember Elkins made a motion to approve Resolution 561 in the amount of \$41,666.80 as presented. Councilmember Pritt seconded the motion. With Four (4) in favor and two (2) absent (Johnson and Little) the motion carried.

COMMUNICATIONS FROM THE MAYOR:

- Stated that City Manager Misty Hill had been named the President of the West Virginia Municipal League City Manager Association. She also noted that City Treasurer Susan Honaker had been named the President of the WV Finance Officer Association.
- The City received a thank you note from the PSD#1 for help with the sewer project on Brush Road and Rolling Hills.

- The City received a thank you note from GVT, Carnegie Hall and the Greenbrier Valley Choral for the production of the Hunchback of Notre Dame. Noting that Mayor White was a surprise guest star in the production.
- The City received a letter from the Lewisburg Fire Department announcing the election of their corporate officers and the endorsement of Joseph Thomas as Fire Chief.

COMMUNICATIONS FROM THE CITY MANAGER:

- City Manager Hill stated crews are slowly beginning to put equipment online at the water plant. She noted the plant has gone from having 3 filters to 6 filters. She stated the plant will not be fully until the new intake is completed. She said that could take several months. She stated that during Fair Week the water plant experienced a electricity outage. Crews worked hard to keep the water plant going using a small generator. Hill stated completing this water plant upgrade is going to be a big thing for the community.
- City Attorney Tom White is currently reviewing the Mon Power easement agreement for lot 40 on Wildwood Avenue.

Councilmember Pritt made a motion to table approval of the Mon Power easement agreement for lot 40 on Wildwood Avenue until the September City Council meeting. Councilmember Elkins seconded the motion. With Four (4) in favor and two (2) absent (Johnson and Little) the motion carried.
