City Manager Misty Hill stated the City needs to negotiate with Mon Power to have an electric pole moved at the West Parking Lot. More time is needed until an agreement for the placement of the pole can be reached between the City of Lewisburg and Mon Power. Councilmember Elkins made a motion to table the Mon Power easement for West Parking lot until more information can be presented. Councilmember Pritt seconded the motion. With all in favor the motion carried.
