Resolution 572 Water System Improvement Project Pay Request 31

Mayor White made a motion to approve Pay Request 31 in the amount of \$1,062,189.36 for Resolution 572 Water System Improvement Project Pay Request 31, as presented. Councilmember Pitt seconded the motion. With all in favor, the motion carried.

Contract for Generator Services (Water Plant, New Intake, and The Retreat)

City Manager Hill stated that The Retreat contract is not included at this time, as the current generator will need to be tested before entering a contract.

Councilmember Pritt made a motion to approve the Contract for the Intake and Water Plant in the amount of \$15,563.69 for a duration of three (3) years. Councilmember Little seconded the motion. With all in favor, the motion carried.

The Lost Trail Studio Training Video

Mayor White made a motion to approve the Lost Trail Studio Training Video on the Belt Press in the amount of \$6,514.00. Councilmember Johnson seconded the motion. With all in favor, the motion carried.
